**ASSUMPTION OF RISK:** I acknowledge that my child’s participation in the Events may involve some physical risks of injury, given the physical nature of the sport of soccer, and we, the parents, freely and voluntarily choose to accept these risks on behalf of our child.

**INDEMNITY:** I hereby irrevocably and unconditionally indemnify and hold harmless Discovery, its officers, directors, employees, affiliated companies, JPSFA, ForwardZone and agents, against any and all claims, liabilities, losses, injuries, theft, costs, expenses (including reasonable attorneys’ fees) and damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever from our child’s participation in any way howsoever in the Events and which I, the child, their families and/or dependants may suffer and/or incur.

**INCAPACITY & MEDICAL TREATMENT:** In the event that my child is incapacitated, I hereby grant permission to the leader/organizer of the Events to render or arrange for immediate medical or other treatment as may be immediately necessary and agree that I shall be fully responsible for any costs arising out of such medical or other treatment.

**PERMISSION TO BE FILMED & USE OF LIKENESS IN ALL MEDIA:** I acknowledge that Discovery and JPSFA may be filming and/or photographing activities for promotional, advertising, or other commercial purposes and hereby consent and agree that Discovery and JPSFA/or its agents may do so. I hereby irrevocably grant Discovery and JPSFA (and its affiliated companies and agents) the right in perpetuity and throughout the world, without any expectation of compensation, to use such material, as well as the portrayal of my name, image, likeness, and voice, in ANY media and on any printed material, in connection therewith for the purposes of promoting or advertising Discovery activities.
